The Sweepstakes is subject to all applicable federal, state and local laws and regulations. 2. **Sweepstakes Period:** The Sweepstakes starts at 9:00:01 AM Central Time (“CT”) on December 1, 2024, and ends at 11:59:59 PM CT on December 21, 2024 (“Sweepstakes Period”).
3. **How to Enter.** There will be two (2) separate entry pools in this Sweepstakes: a Dog prize pool where winners in the pool will receive a dog prize (“Dog Pool”), and a Cat prize pool where winners in the pool will receive a cat prize (“Cat Pool”). To enter the Sweepstakes, open your myPurina app (on Apple or Android) and log in using your Purina Perks member log-in (“Rewards Account”). Once logged in, open the Rewards Catalog and find and add the Dog or Cat Sweepstakes Entry item to your Rewards Cart, and complete the checkout process to receive one (1) entry into the Sweepstakes random drawing. You may enter the dog and cat sweepstakes, but you may only enter each sweepstakes one (1) time. All entries must be submitted by 11:59:59 PM CT on December 21, 2024, to be eligible for the Sweepstakes random drawing. Sponsor is not responsible for any technical issue relating to the entry.
